

SVS BROWN SHIPLEY BALANCED FUND

Factsheet to 31 January 2025

Fund Objective

The Fund aims to achieve growth through a combination of capital and income over the medium term (at least five years). The Fund will invest, directly and indirectly, in a mixture of shares and fixed interest securities (being sovereign, investment grade and non-investment grade bonds). The allocation between the shares and fixed interest securities in which the Fund invests will be actively managed and will vary in response to short term market conditions. However, the Fund operates a balanced strategy, maintaining a balance between shares and fixed interest securities, with the allocation to shares remaining within a 40% to 85% range. The Fund excludes issuers that derive more than 10% of revenue from thermal coal extraction or power generation, those that are involved in controversial weapons, issuers subject to EU arms embargoes and those that are deemed in violation of the UN Global Compact principles for over 3 years. In addition, the Fund integrates environmental, social and governance (ESG) factors in its investment process.

Commentary

January was generally good for risk assets despite a volatile end to the month. Technology stocks saw heavy losses following news of increased competition in the artificial intelligence space from China's DeepSeek. Earlier in the month, markets largely took their lead from macro-economic data releases as investors looked for clues as to the future path of central bank interest rates.

Strong US jobs data early in January followed by lower than expected inflation data pulled markets in both directions although investor focus started to shift towards President Trump's inauguration in the second half of the month. Markets were supported by prospects that potential trade tariffs may not be as severe as first thought, whilst Trump's comments that he wanted to see interest rates lower supported risk assets as yields fell. The end of the month, as mentioned above, saw markets give back some of their gains with the technology sector suffering the most.

During the month there were some changes with regards to the equity market 'insurance' product that is held in the portfolio. The European equity warrant was repriced at zero cost to better reflect market conditions, whilst a new warrant on the US equity market was added to the portfolio in late January to provide some downside protection in the region.

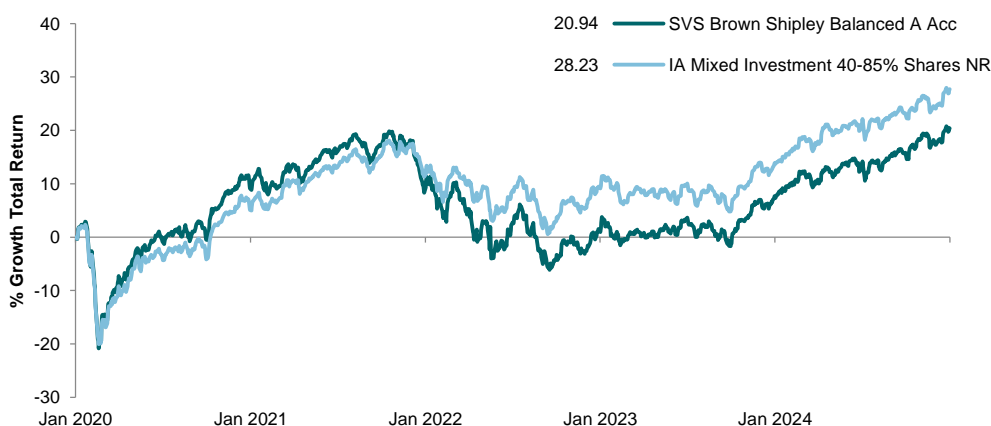
Overall, the portfolio continues to hold a marginally overweight equities position versus bonds compared to the long term strategic weighting, whilst also being positioned to navigate uncertainty both in markets and in the global economy.

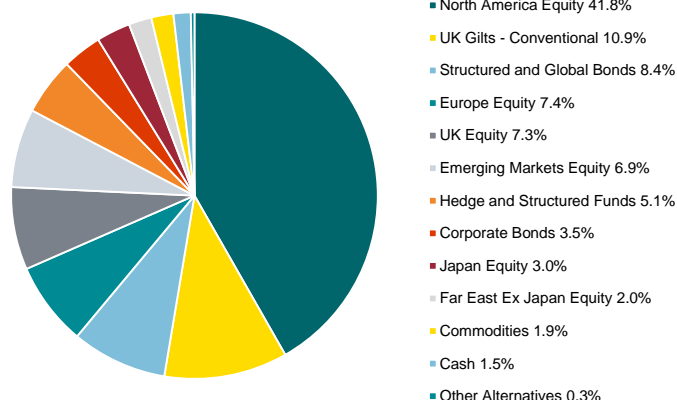
