

SVS BROWN SHIPLEY CAUTIOUS FUND

Factsheet to 31 August 2025

Fund Objective

The Fund aims to achieve growth through a combination of capital and income over the medium term (at least five years). The Fund will invest, directly and indirectly, in a mixture of shares and fixed interest securities (being sovereign, investment grade and non-investment grade bonds). The allocation between the shares and fixed interest securities in which the Fund invests will be actively managed and will vary in response to short term market conditions. However, the Fund operates a cautious strategy, meaning that the allocation to shares, will remain within a 0% to 35% range. The Fund excludes issuers that derive more than 10% of revenue from thermal coal extraction or power generation, those that are involved in controversial weapons, issuers subject to EU arms embargoes and those that are deemed in violation of the UN Global Compact principles for over 3 years. In addition, the Fund integrates environmental, social and governance (ESG) factors in its investment process.

Commentary

A positive July for risk assets was followed by good returns for most asset classes in August. Broad based measures of both equity and bond markets ended the month in positive territory as a combination of well received company reports and supportive macroeconomic data led to gains. A strong second quarter earnings season helped investor sentiment whilst the prospect of a more dovish US Federal Reserve following weaker than expected jobs data in the region supported markets.

Equity markets were led by Japanese stocks following the US-Japan trade deal announced at the end of July as well as being supported by positive economic data for the second guarter. UK stocks lagged, however, with gains held back by higher than expected inflation data for July.

Fixed income markets were mostly positive over the month with higher risk sectors and regions outperforming their lower risk counterparts. Expectations for more interest rate cuts in the US helped sentiment, leading to gains in particular in Emerging Market debt and high yield bonds. Corporate debt also performed


Sovereign debt was mixed with US treasuries posting gains over the month whilst European and UK government bonds both lagged. European government bonds faced headwinds as stronger than expected Q2 economic data from France and Spain saw bond yields in the region rise (bond prices fell) whilst UK debt struggled on the back of the afore-mentioned higher inflation print.
